TO APPLY FOR A SCHOLARSHIP

A **limited** number of Scholarships (**maximum value of \$250**) are available to those requesting individual speech evaluations and would not be able to attend without financial assistance. Just complete the registration form and indicate that aid is requested by checking yes at the bottom of the form. The FLA will utilize two methods of payment, **Option A - Lump Sum**, which is payment of \$250 by check at the banquet or **Option B- Actual Cost**. This latter method is new to us and details are being worked out as this is being written. You must call or email Carl Kilmer, President for pre-approval for this option. Our goal is to offer aid to those needing speech evaluations and unable to attend otherwise. These funds are limited so we hope to limit aid to those in real need. Scholarships are courtesy of a grant from the American Cancer Society, Florida Division, which allow us to include speech evaluations in our Program and grant financial aid. FLA ELECTIONS

The FLA has historically chosen to be officially governed by its members with an Executive Committee operating as a Board of Directors between its Annual Meetings. This Executive Committee is composed of the officers: President, 1st and 2nd Vice Presidents, Secretary and Treasurer. Also included are our Medical Advisor, Director of Education and up to 4 Members at Large. Secretary and Treasurer may serve for a 6 year term While there are no term limits on Members at Large., they are required to be re-elected each official election. Each Vice President serves a 2 year term and moves up on each election in order to gain experience for ultimately becoming President. The President may normally only serve a 2 year consecutive term. Nominations are selected by an appointed subcommittee and if approved will be presented to members at our official elections. **SPEECH EVALUATIONS
AND THERAPY DURING
THE
ANNUAL MEETING**

New laryngectomees, or others wishing to improve their speech or to try another method, can come to the **FLA Annual Meeting (AM)** for speech evaluation by FLA staff **licensed and certified Speech-Language Pathologists**. A well-rounded program is being presented that is geared specifically to the Laryngectomee. The meeting will be held at a new location, the Plaza Ocean Club Resort, Daytona Beach. **NEW** this year, follow-up therapy sessions for those found in need during speech evals. **DON'T MISS THIS OPPORTUNITY! FREE! INCLUDED IN REGISTRATION FEE.** The **FLA** is sponsoring **FINANCIAL GRANTS** up to **\$250** for those who request speech evaluations and need financial assistance in order to attend.

Do you qualify for a grant?

Criteria for the FLA grants:

- *Must be a Florida resident.
- *Must pre-register for the convention and attend all Annual Meeting instructional sessions as well as the banquet.
- *Must lodge in the meeting hotel.
- *Must pre-register for speech evaluations (see bottom of registration form).

*Must provide specific justification for Option B by phone or email to Carl Kilmer, President. (see rt column, pg 4 for contact info)

Priority for a grant will be given to laryngectomees who are 5 years or less from date of surgery. (or having significant problems)– explain on registration form.

Grants are limited and awarded on a first come basis. Specific amount may vary. Priority given to those unable to attend without financial aid.

Option A is a lump sum payment at end of the Annual Meeting.

Option B is partial actual cost with early payment subject to pre-approval & details to be developed. It is designed to end the need to pay out-of-pocket and then be reimbursed later.
